

## ADDENDUM TO "DATA PROTECTION NOTICE"

Data protection notice pursuant to the EU General Data Protection Regulation - GDPR (*EU-Datenschutz-Grundverordnung* (DSGVO)) for the Optimist Team Cup

The following information provides you with an overview of how your personal data will be processed by us, as the host club, and about your rights from data protection law.

2. In order to organise the regatta, we will process the personal data which the regatta participants give to us on registration. The data which we will process is the name, address, email address, club, boat type, sailing number and for regattas with age restrictions, the year of birth.

Also, during the regatta, results, mathematical and optical analyses, position tracking, including in the form of competition analyses, will be matched to the participants and will be made public, e.g. in the form of start, participant and result lists on the blackboard, the regatta and the club's home page [www.optiteamcup.de](http://www.optiteamcup.de) , [www.pyc.de](http://www.pyc.de), or on Facebook [www.facebook.com/optiteamcup/](https://www.facebook.com/optiteamcup/).

During the regatta the necessary data, especially in the form of result lists, will be sent to the responsible class association International Optimist Dinghy Association, Agnetevej 11, DK-9000, Aalborg, DENMARK to generate a ranking list. The data will also be sent to the Deutscher Segler-Verband e.V., Gründgensstraße 18, 22309 Hamburg (German Sailing Association - DSV) to evaluate and monitor the competition notices and results. The DSV will post the name, club and position of the six best participants in championships on its website. International Optimist Dinghy Association and the DSV are obliged only to use your data for this event, including preparation and post-processing, including rankings and sharing rankings and results with other clubs. Commercial use is prohibited.

In connection with its purpose (the promotion of the sport of sailing) the club will publicise personal data, texts, photos and films of the regatta participants in the form of a report in its club magazine, on its homepage and on social media. This data may only be transmitted to print-, tele- and electronic media for the purposes of the sport coverage. This concerns in particular starting lists; participants lists and results lists for the regatta. The publication/transmission of the data is hereby limited to photos, film, name, club, association and – if needed for sports purposes – the age or year of birth.

3. The participants can refuse to permit host club to publish individual photos at any time. From the point at which the objection is received the club will not publicise/transmit the photos and must remove any photos from their website and social media.

By registering for the regatta and thus acknowledging the rules and to this data protection notice, the participant in the regatta agrees to the collection, processing (saving, altering, transmitting) and use of their personal data in the aforementioned degree and scope. Any other use of the data by the host club is only permitted if the host club is obliged to do so under statute. The data may not be sold.

For the purposes of the statutory provisions of the EU General Data Protection Regulation every participant has the right to information about the data received regarding his/her person, the recipient of such data and the purpose of saving, rectifying, erasing or blocking this data. In addition, he or she has the right to withdraw the agreement to collect, process and use this data at any time with effect for the future and to contact the responsible regulatory authority *Dr. Stefan Weger*. Once the regatta has been completed the personal data will be deleted again. The results list of the regatta will be archived for sports-related purposes.
